## WARRANTY POLICY

### Coverage

The Stealth Products Limited Warranty applies only to products that are from an authorized Stealth Products distributor. Stealth Products Limited Warranty covers products manufactured by Stealth Products and does not cover products which may be sold or delivered together with your Stealth Products products. Refer to the warranty periods below for specific component coverages.

### Terms

If, during use within the warranty period, a product fails, Stealth Products will replace defective parts in the product using new or refurbished parts. All defective products and parts replaced under this limited warranty become property of Stealth Products, and are required to be returned to Stealth Products.

- Stealth Products is responsible for the repair or replacement of the defective parts only.
- Stealth Products is not responsible for incurred labor costs of repairing or replacing the product.
- Stealth Products is not responsible for shipping charges for defective or replacement products.
- All products or parts replaced by Stealth Products will be under warranty for the remainder of the warranty.
- Determination of the cause of failure will be at the discretion of Stealth Products.
- Determination of replacement or repair will be at the discretion of Stealth Products.

There are no express warranties. To the extent permitted by law, any implied warranty, including the implied warranties of merchantability and fitness for a particular purpose, shall not extend beyond the duration of this warranty. The remedy for violations of any implied warranty shall be limited to the repair or replacement of the defective part only. Stealth Products, LLC. shall not be liable for any consequential or incidental damage whatsoever. This warranty gives you certain legal rights. You may also have other legal rights that vary by region.

### Limitations

#### The Stealth Products, LLC. Limited Warranty **DOES NOT COVER:**

- Product failure due to abuse, misuse, misapplication, or improper maintenance.
- Product failure due to products used in conjunction that are not manufactured, approved, or sold by Stealth Products.
- Product failure due to operation outside of safe storage and environmental conditions detailed in the User's Manual, or acceptable conditions for similar product usage by the industry's standards of best practices.
- Product failure due to repair from a third party or outside company.
- Products that have been lost or stolen.
- Products that have been modified without written and signed approval from Stealth Products.
- Products that have a warranty seal that has been broken, or altered.
- Products that do not have valid a serial number.
- Products that have a serial number that has been altered, cancelled, or removed.
- Electronics that have not been registered with Stealth Products, LLC. prior to product failure.
